WHAT DOES THIS LIMITED WARRANTY COVER?

Subject to the exclusions and limitations set forth in this Limited Warranty, we warrant to You that each Product will be free from defects in material and workmanship, under normal use and maintenance, for the applicable warranty period stated below.

WHAT IS THE WARRANTY PERIOD APPLICABLE TO RESIDENTIAL PURCHASERS?

The warranty period for Your Product begins on the date the Product was purchased, whether purchased by You or by a third party on Your behalf.

Your warranty is only valid if you use the dwelling as your primary or secondary home and does not extend to future owners if the property is sold.

WHAT THIS LIMITED WARRANTY DOES NOT COVER:

The Limited Warranty does not apply to any Product:

- installed or used outdoors;
- used for purposes for which it is not designed or intended by Us;
- which has been subjected to misuse, vandalism, abuse, negligence, accident, or unauthorized modifications;
- which has been improperly stored (if the Product must be stored, it should be covered and stored in a humidity and temperature controlled environment, away from direct sunlight);
- which has been improperly installed, cleaned, or maintained
- damaged by fire, flood, acts of God, or other external causes beyond our control;
- varying in color and characteristics due to age, sunlight, smoke, or other environmental conditions;
- exhibiting any effects on the color and/or integrity of the finish or appearance due to the use of abrasive cleaners, cleaners that contain chlorine, acidic cleaners, scuffing sponges or steel wool; and/or exhibiting normal wear and tear.

In addition, natural woods may vary in color and characteristics and exhibit subtle changes as they age. For example, painted doors, drawer fronts, and face frames may eventually have visible cracking around the joint area, and cabinet colors may darken or lighten over time. These variations are considered to be the nature of the material in relation to their environmental exposure and are not covered under this Limited Warranty.

Forevermark Cabinetry



Forevermark Cabinetry warrants to be free of manufacturer defects that are avoidable, and unnatural defects in material and workmanship under normal use, for five (5) years from the date of purchase by the original consumer purchaser (except for cabinets with painted finishes, which are limited to a two (2) year warranty).

WHAT THIS LIMITED WARRANTY DOES NOT COVER:

Does not cover or apply to any defect that is not caused by TSG. This does not cover or apply to products that have been misused; mishandled; abused; improperly stored or installed; modified; or subject to excesses of moisture or extreme temperatures, abrasive or citrus cleaning products or normal wear and tear.

TO BE EXPECTED:

Differences in grain pattern and color should be expected. Wood characteristics naturally occur, such as variations and color softening in cabinets and a natural occurrence due to species, age, character of cabinets and exposure to sunlight. Replacement cabinets may not match display samples and/or existing cabinets. Such variations are not considered defects.

The limited liability warranty applies only to defects, and does not apply to yellowing, aging or warping of any wood product. Every species and grade of solid wood behaves in such a way as to eventually result in hairline cracks. Painted finishes react differently than stained finish with normal wood movement, and climatic conditions may result in breaks in finish, joint and panel lines. Doors that are warped in either direction do not exceed normal material expectation and are not included or covered by this limited liability warranty.
